Transportation to and from Training Venue/Parking

There is less than adequate public transportation to and from and around the training venue; therefore, we recommend coordinating with other trainees from your Region to organize carpools or ridesharing.

If you are in a rental car/GOV/POV, please know there are designated parking spaces at the training venue (see last page). Please avoid parking in undesignated parking spaces especially those that are designated for the FBI.

Other Helpful Hints

Although the training venue is in a commercial park setting, the training facility is quite comfortable. The conference room can hold 60-people, there is a small kitchenette with a microwave and refrigerator available. If you want to bike to the work location from your hotel, a single shower is available for you to use

Clothing: All training will be conducted inside the training venue. Wear comfortable clothing. Bring a light sweater or such if you run on the cold side.

Food & Beverages: As comfy as the training venue is, the selection of nearby food and beverage establishments is lacking. As such, we highly recommend you eat breakfast and drink the caffeine-laden beverage of your choice at home or your hotel or bring with you. There aren't any coffee shops within walking distance, but we will have drip coffee available.

You will be given an hour each day for lunch. There are a couple lunch spots within walking distance, e.g., Subway, Taco Truck. Other lunch establishments can only be reached via car. Since there is a refrigerator on the premises, you can always bring your own lunch and snacks.

IT Needs: You will need to bring a laptop to this training, and your CAC/PIV card. In the course we will spend time exploring and using EPA's Web Emergency Operations Center (WebEOC) system; each person will need a laptop. You will need to contact the EPA's Emergency Response Team (ERT) to gain access to WebEOC – they can be reached by email at ertsupport@epa.gov.

The training room has the "OneEPA" wireless network and your EPA computer should automatically connect to the network. You should bring a thumb drive and your EPA Incident Management Handbook if you have been issued one.





Getting to the Warehouse

There are very limited public transportation options. You will need a vehicle to get to the warehouse, and to get from the warehouse to a hotel and food.

Driving Directions from SeaTac Airport

A. SEATTLE-TACOMA INTERNATIONAL AIRPORT (SEA)

- 1. Start out going NORTHWEST. (0.2 mile)
- 2. Take the ramp toward WA-99/INTERNATIONAL BLVD/CELL PHONE LOT/OVERHEIGHT PARKING (0.7 mile)
- 3. Turn RIGHT onto S 170TH ST (0.0 mile)
- 4. Turn LEFT onto INTERNATIONAAL BLVD/PACIFIC HWY S/ WA-99 N. Continue to follow PACIFIC HWY S/WA-99 N (3.1 miles)

- 5. Merge onto WA-99 N toward SEATTLE (2.0 miles)
- 6. Take the DES MOINES DR/14TH AVE SO exit (0.1 mile)
- 7. Take the 14^{TH} AVE S ramp (0.1 mile)
- 8. Turn LEFT onto 14TH AVE S (0.2 mile)
- 9. Turn RIGHT onto S DIRECTOR ST (0.0 mile)
- 10. Turn RIGHT onto 15TH PL S (0.0 mile)
- 11. Turn LEFT onto S 92ND PL (0.1 mile)
- B. 1620 S 92ND PL BLDG K, SEATTLE, WA 98108-5134

- 1. Head NW on 6TH AVE toward UNIVERSITY ST. (0.1 mile)
- 2. Turn LEFT onto UNION ST (0.3 mile)
- 3. Turn LEFT onto 1ST AVE (0.4 mile)
- 4. Turn RIGTH and merge onto WA-99 S (3.8 miles)
- 5. Merge onto WA-99 S (0.1 mile)
- 6. Merge onto WA-509 S/WA-99 S via the ramp to W MARGINAL WY/S PARK/BURIEN (0.8 mile)
- 7. Take the exit towards S PARK (0.2 mile)
- 8. Merge onto 2ND AVE SW (0.4 mile)
- 9. Continue onto WA-99 S/W MARGINAL WAY (1.4 miles)
- 10. Take the exit towards 14TH AVE S (0.4 mile)
- 11. Merge onto DES MOINES MEMORIAL DR S (0.3 mile)
- 12. Turn RIGHT onto S DIRECTOR ST (0.1 mile)
- 13. Turn RIGHT onto 15TH PL S (0.0 mile)
- 14. Turn RIGHT on S 92ND PL (0.1 MILE)
- 15. 1620 S 92ND PL BLDG K, SEATTLE, WA 98108-5134


Parking

There are 20 parking spaces associated with the warehouse. Parking is available on the street and may be available throughout the industrial park.


Access

The facility is one bay in a multi-bay building in an industrial complex.


