### **Weight-of-Evidence Decision Making for RI/FS at Munition Response Sites**

#### **Course Description:**

Using the Munitions Response Quality Assurance Project Plan Toolkit Module 1: Remedial Investigation (RI)/ Feasibility Study (FS) as a guide applied to an example Munitions Response Site, this training course demonstrates weight-of-evidence decision making for the RI/FS phase of investigation. This two-day training course, which employs both large and small group discussions, covers project planning, data quality objective development and data usability assessment. As a prerequisite to ensure a baseline knowledge of MRS investigations, attendees are encouraged to take the online ITRC training course, “Quality Considerations for Multiple Aspects of Munitions Response Sites” (<https://qcmr-1.itrcweb.org/training/>).
