Building Security/Admission into the EPA Headquarters Building

The Federal Remediation Technologies Roundtable (FRTR) meeting will be held Tuesday, May 16, at the William Jefferson Clinton West Building (WJC West) in Washington, DC. Please arrive at the WJC West building by 8:30 a.m. to allow time for security screening and to be escorted by an EPA employee to the meeting room.

All packages, briefcases, handbags, etc., will be scanned, and you may be subject to security screening through metal detectors and/or x-ray equipment. Visitors must sign in and present photo identification, such as a state driver's license. Driver's licenses must comply with the [REAL ID Act requirements](#). Driver's licenses from states and territories that do not comply with the REAL ID Act will not be accepted as identification.

The guard will then issue a visitor's badge that must be worn at all times. Visitors bringing laptop computers into the building will be required to take their laptops out of the bag and may be required to document their computer's serial number as part of the sign-in process.

Note: Prior to traveling to the meeting, all individuals should complete a self-assessment following the [COVID-19 Workplace Safety Plan](#).

Parking

Local participants can park in the surrounding parking garages if necessary. Parking rates vary per garage.

Ground Transportation

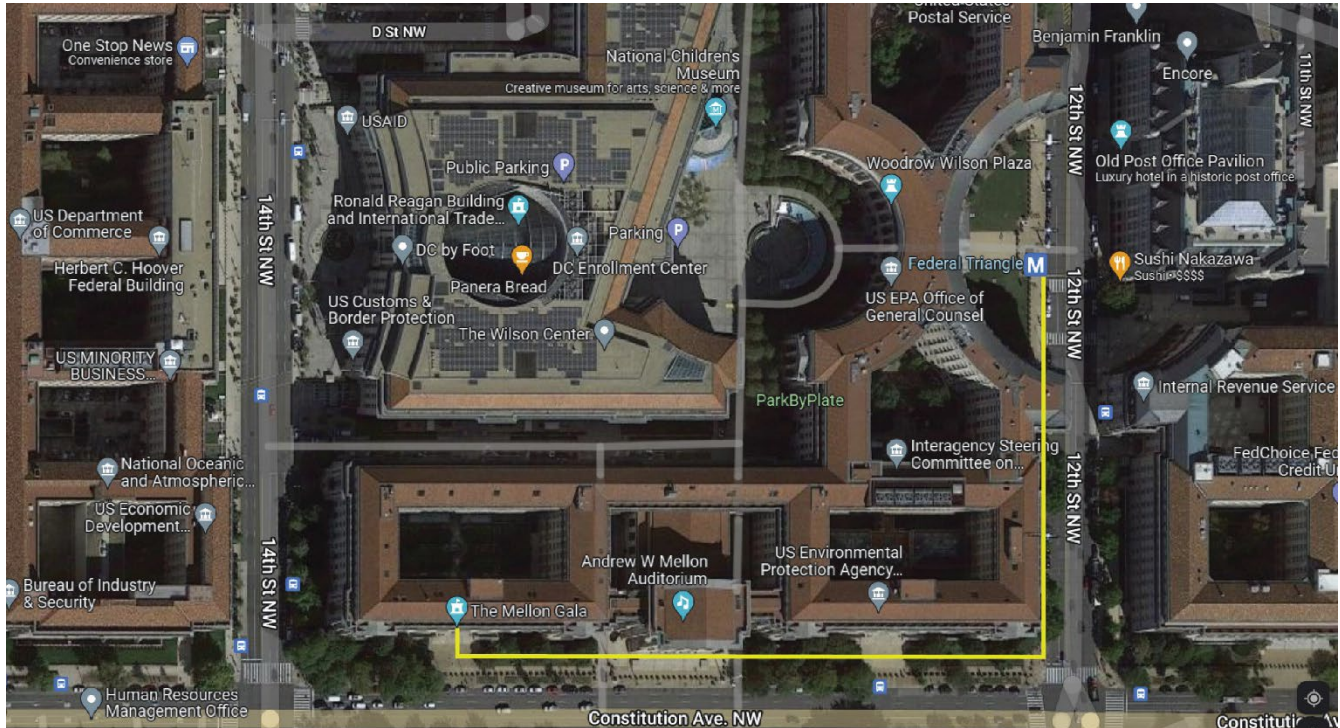
From Reagan National Airport

Metro:	<p>Metro transportation is available to and from the National Airport Metro Station and the Federal Triangle Metro Station. There is an elevated Metrorail station connected to the concourse level of Terminal 2. The fare from the airport to the Federal Triangle Metro Station (Blue, Orange, and Silver Lines serve this station for local travelers) is \$2.60 with a SmarTrip card, which can be purchased at the station (\$1.30 SmarTrip Senior/Disabled/Medicare). Board the blue line train heading north toward New Carrollton and ride approximately 25 minutes until the Federal Triangle Metro Station.</p> <p>From the Federal Triangle Metro Station elevator, walk approximately 0.1 mile south toward Constitution Ave NW. Turn right and continue 0.15 mile to the visitor entrance. (See Location Map below).</p> <p><i>Note: Metrorail is under maintenance as of September 10, 2022. While this is not expected to affect the route between DCA and EPA Headquarters, please refer to WMATA's schedule & map tools for updates: www.wmata.com.</i></p>
Taxi/ Ride Service:	<p>Taxi service is on a first-served basis. A DCA Taxi Dispatcher is available at designated taxi stands to ensure you are placed with a taxi. From Terminal 1, proceed out the exit doors at baggage claim and turn right. The Taxis are located on the curb closest to the Terminal. From Terminal 2, proceed to the baggage claim lower level (level one). Walk indoors to Doors 5 or 6, then proceed outside to the terminal curbside. You will find the taxi dispatch location clearly marked. Taxi fare from Reagan National Airport to the EPA Headquarters is approximately \$20-25 each way.</p> <p>Ride Services are available in the local DMV area using your smartphone to select the appropriate pick-up zone and coordinate directly with their driver. Uber and Lyft for a single rider is approximately \$15-25. Green flags located outside on the outer terminal curb designate the appropriate pick-up loading zones. There are three designated areas for pickup. From terminal 1, customers can meet their ride on the third (outer) curb; from terminal 2, customers can meet their ride on the Baggage Claim (Arrivals) Level-1st Floor on the outer curb; and customers can meet their ride at the designated pick-up and drop-off location across from the Rental Car Shuttle Bus shelter located on National Avenue.</p>
Rental Car:	<p>Several rental car companies are available. Board the "Rental Car/Garage Parking" shuttle, which stops at Doors 4 and 8 on the Baggage Claim (arrivals) level (Level 1). Get off at the Parking 1/Rental Car stop. Walk following the Parking 1 signs, approximately 10-15 minutes from Terminals 1 & 2. Shuttle:	<p>Some nearby hotels offer airport shuttle service. From terminal 1, customers can meet their shuttle bus on the middle curb. From terminal 2, customers can meet their shuttle bus on the Baggage Claim (Arrivals) Level-1st Floor.</p>
