Sleeping Room Reservations

What to Pack for the Philadelphia Area

Average temperatures in March and early April range from 32°F at night to 52°F during the day. Please be advised that the temperatures in the training room do not reflect temperatures outside. Be sure to pack a jacket or sweater to wear while you attend the training.

Dining

Travel Information

The Philadelphia area is served by [Philadelphia International Airport \(PHL\)](#). The Philadelphia area is also serviced by Amtrak. The main train station is the 30th Street Station (Philadelphia Station, 2955 Market Street).

Philadelphia, Pennsylvania is located in the Eastern Time Zone.

Ground Transportation

Public Transportation: The Southeastern Pennsylvania Transportation Authority (SEPTA) provides train service from the airport to Center City. It also provides numerous transportation options throughout the city. To explore the various options, including a mapping feature, visit <https://www5.septa.org/>. Directions on using train service from the airport to the hotel and from the Amtrak Station to the hotel are described below.

- **Airport:** The train service that runs from the airport to Center City is referred to as the Airport Regional Rail Line. Trains run every 30 minutes on weekdays and operate from 4:13 am to 11:03 pm (Center City to Airport) and from 5:07 am to 12:07 am (Airport to Center City). On weekends, trains run hourly and operate from 5:13 am to 11:13 pm (Center City to Airport) and from 6:07 am to 12:07 am (Airport to Center City).

A one-way ticket is approximately \$6.75. The ticket can be purchased at kiosks at the airport or any train station using credit/debit cards, cash, tokens, and electronic payments including Apple Pay, Google Pay and Samsung Pay. If a ticket is purchased on-board, it is \$8.00.

To get to Linwood from the airport via train, take the Airport Regional Rail to Suburban Station in the Center City (25 minutes). From there, you can take the SEPTA bus route 114 or 115 toward Delaware County, which stops near Linwood. The bus ride is approximately 50-60 minutes depending on traffic and schedule. Walk or take a local taxi from the bus stop to the hotel in Linwood.

- **Amtrak:** The Amtrak trains arrive at Philadelphia's 30th street station. From there, take SEPTA's Media/Elwyn Regional Rail Line to Linwood/Chester station, which is the closest stop to Linwood. From the station, local taxi or rideshare can get you to your hotel. Fare from the regional rail is approximately \$8.

Shared Ride Service: Uber and Lyft provide transportation from both the airport and 30th Street Station to Linwood. From the airport rides range from \$25-\$40 one way depending on traffic and time of day. Travel time is approximately 40 minutes. From 30th street station, rides range from \$15-\$25 one way and take approximately 25 minutes.

Taxi fare: Taxi fare between Philadelphia International Airport and Linwood is approximately \$45 one way, not including gratuity. Taxis are located at Zone 5, South Commercial Roadway. Taxi fare from 30th Street Station to Linwood is approximately \$25 one way, not including gratuity. For a list of cab companies, see <https://phl.org/to-and-from/taxis-and-limousines>.
